Principal Report, Term 1, 2022

Thank you to the P&C and College Board for their support over the past year. We are continuing to work within exceptionally challenging times, so this ongoing support and advocacy for students and college operations and processes has become even more important.

We have had a positive start to the year; an increase in overall student numbers, new staff and with only a handful of minor behaviour issues. Staff attribute this to the positive behaviour approach we developed over the past 12 months and a move away from punitive punishment, as a way to manage student behaviour.

Current roll numbers are sitting on 141 (although some of these students have recently taken up traineeships and apprenticeships) Year 12 - 41 Year 11 - 58 and Year 10 - 42.

We will be trialling the new WACoA Application and Enrolment process, this year and hope to begin interviews within the next week or so.

We are still to secure a Math teacher for the rest of this year, to backfill Mr Manez's move to Boddington DHS.

In Term 2 we will have 2 final year pre-service teachers. One will be working in Trades with Mr Ryan and the other in Class, alongside Mr Dougall.

The new Trucker style caps were organised during the holidays and have proven popular. There was an initial order of 100 placed to gauge popularity. Students currently have 3 options for hats, so there should be no issues with non-college hats being worn.

Staff have been reminding students to wear the correct uniform, most are doing the right thing but some girls have been reminded that 'leggings' are not part of the uniform.

The face to face Board Training that was to be held at East Narrogin PS has been cancelled. We will endeavour to get access via IKON, to all Board Members should they wish to complete the online modules (Mary to set up EV number for all members).
